Aerial Lift Platform (MEWP) Training

Aim

The aim of this course is to provide the workers with an awareness of the need for Mobile Elevated Work Platform (MEWP) training and the knowledge and skills necessary when working with MEWP's. Trainees will receive training on the equipment and procedures to safely use different types of lifts.

Content

This program will meet or exceed applicable government regulations for the training of employees operating MEWP's. Trainees will acquire knowledge and skills through a combination of lecture presentations, group discussions, film presentations, equipment demonstrations and performances based on MEWP's. Trainees are required to complete written and practical testing in order to receive course certification.

Areas of study will include the following:

The operator will be trained to CSA standard B354.7 and the training will include:

- Risk assessments provided by the employer in relation to the work site.
- Selection of the suitable Ariel Lift.
- Manufacturer's manuals and locations on the lifts.
- Inspections and maintenance obligations specified in the manufacturer's manuals.
- Factors affecting the stability in the operations of the MEWP.
- Hazards identification / daily workplace inspection.
- General knowledge of the MEWP.
- Malfunctions with the MEWP and how to address the situation.
- Personal Protective equipment requirements.
- Practical training will include hands-on demonstration and use of arial lift equipment.

DURATION

Four to six (4-6) hours.

PREREQUISITES



Trainees are expected to be in a good state of health and physically capable of fully taking part in all program activities. Trainees are expected to participate in all physical training requirements. Trainee is to hold a valid fall protection certificate prior to taking this course.

A valid Government Identification is required and must be presented for registration and to the instructor on the first day of course commencement. (Driver's License, Passport, Vantage Card)

CERTIFICATION

All persons who successfully complete the course based on the performance standards will receive:

- A Survival Systems Training certificate for Aerial Lift Platforms. (MEWP)
- Expiry is every 5 years.

TERMS OF PAYMENT
